Features

- **Multi-Language** allows for the creation of multiple languages to be used for all Sage 100 screens, menus, and reports. One language may be setup for each user. The product also has Language Templates that can be used, such as Spanish and French. Different dialects of a language can be created by copying one language to another, and then tailoring that language to a certain dialect.
- **Multi-Language** also allows for a global substitution of specific English phrases (i.e. “Inventory Code” instead of “Item Code”) to accommodate individual business preferences.

Section B: Getting Started

CAUTION

- **If you reinstall or upgrade one of the Sage 100 modules listed in the following table, you must also reinstall this Enhancement.**
- Enhancements from different Master Developers are generally not designed to work together. If installed together, problems are likely to occur.
- **Check with DSD before installing more than one Enhancement.**

Installation

1. **Back-up:** Exit all Sage 100 sessions. Back-up existing Sage 100 data.
2. **Check Levels:** Sage 100 module levels **must match** those listed above.
3. **Run Enhancement Setup Program:** Save the executable installation program (sent to you or downloaded from our website) in a convenient location on the Sage 100 server. Launch the program from Windows Explorer or by selecting Start/Run, and then browse for the file in the location you saved it. Follow on-screen instructions.
4. **Send your Sage Serial Number to your DSD Representative:** Send your Sage Serial Number to your DSD representative in order for us to send you back the encrypted keys to unlock your system. This serial number can be found in Library Master\Setup\System Configuration, Tab 3. Registration as Serial Number.
5. **Re-Start Sage 100:** Sage 100 will be updated.
6. **Unlock the Enhancement:** DSD Enhancements must be unlocked to run. When any part of the Enhancement is run for the first time, the **DSD Enhancement License Agreement and Activation** window will appear. Follow the steps shown on that window. *You can click the Help button for more detailed instructions.*

Note: On the next page is a screenshot of the DSD Enhancement License Agreement and Activation window.

After accepting the License Agreement, you can then select the type of unlocking that you'd prefer. The choices are File, Web, Demo and Manual Entry.

File Unlock: After receiving your encrypted serial number key file from DSD, and placing that file in the MAS90/SOA directory, selecting this option will unlock all products keys contained in the file. This means you can unlock all enhancements at once using this option.

Web Unlock: If the system that is running the DSD Enhancement *has web access* and you *have sent DSD your Sage Serial number*, you can unlock the Enhancement without assistance using Web Unlock. When this option is selected, the program will attempt to download encrypted serial number key file from DSD *and then proceed to unlock all enhancements contained in the file*.

- The Sage 100 system that is being used must have web access for this option to be effective.
- You can send your Sage Serial Number to your DSD Enhancements sales representative.

Demo Unlock: If a Demo mode is available for the Enhancement you're running, you will be able to Demo unlock the product without assistance from DSD for demo purposes.

- *Creating a Demo Unlock is a good way to temporarily unlock DSD Enhancements off-hours, if you do not have web or email access. Later, you can unlock the product fully, during business hours.*

Manual Entry Unlock: If you want to unlock a single enhancement using a single encrypted key, you can select this option and enter the 64 character key you receive from DSD by copy and paste.

Note: You can also unlock a DSD Enhancement through the **DSD Enhancement Control Panel** found on the Library Master Utilities Menu. Then, select the Enhancement with your mouse from the list of Enhancements and click the **Unlock Product** button on the right side of the window.

7. **Convert Data:** There is no Conversion for this Library Master Extended Solution.

DSD Enhancement Control Panel

Starting with version 3.61, all DSD Enhancement products include DSD's Enhancement Control Panel. The **DSD Enhancement Control Panel is accessed from the Library Master Utilities menu.**



The DSD Enhancement Control Panel is a simple to use yet powerful system to help maintain DSD Enhancements installed on a Sage 100 system. To use it, select an Enhancement product from the list on the window and then click the button, on the right side of the window, which corresponds with the desired task.

View Manual: This button will display the product manual for the selected Enhancement using Adobe Acrobat. For this to be possible, the PDF file for the corresponding manual must be in the "MAS90/PDF" folder in the Sage 100 system. If the file is not present, and the system has web access, the correct PDF file will be automatically downloaded from the DSD website, put into the "MAS90/PDF" folder and then displayed.

Check the Web for Updates: This button will check the DSD website to see what the current build is the selected Enhancement and alert the user if a later version is available. *This requires an ftp web connection on the Sage 100 system.*

Unlock Product: This will cause the DSD Enhancement License Agreement and Activation window to appear. Using this window is described on the previous page. *This button is disabled if the selected Enhancement is already unlocked.*

Unlock All Products: This will cause the DSD Enhancement All License Agreement and Activation window to appear. This window is similar to the one described on the previous page, but has only web and file as options to unlock. *This button is never disabled.*



Convert Data: There is no conversion for this Library Master Extended Solution.

Help: The Help button, located at the bottom right of the window, opens an HTML help file .

Get Adobe Acrobat: Opens the Adobe Acrobat website to the page where Acrobat can be downloaded and installed.


Uninstall Enhancement If this option is available, then selecting this button will start the un-install process, removing the enhancement from the system.

There are also links to the DSD website and the Enhancement page on that site.

Section C: Set Up

Multi-Language

After installation of the product, there will be a new menu item in the Library Master Module: **Multi-Language**, as seen at right.




English Language Builder

Select the **English Language Builder** menu item to create the English Language table that will be the basis for the foreign language substitutions.


The user will be prompted with the warning at the right. The program will then search the Nomads Libraries, Grid Libraries, Message Library, ALE Lookup Files, Menus, Crystal Report Files, Legacy Reports, & Progress Bar Text, to create the English Language Table. This process may take a few minutes.

This will only need to be created once.




Language Maintenance

Select the Language Maintenance menu item to create/maintain a Language Table. Enter a new Language Code or use the Lookup to recall a Table that's already been created.




If a new Code has been entered, the "Origin" side of the Translation grid will be loaded from the English Language Table. The user will enter the Language Description then have the option to Copy the new table from a Template or one of the other Language Codes already created.

If "Copy From Template" is chosen, the user will be asked to select one of the templates on file (either a default template that comes with the product or one created by the user). The template records will then be copied into the new Language Code.




After the records have been copied, the new Table will be displayed with the original English text on the left from the English Language Table, and the new translated text on the right:



After the Accept Button is selected the system will update the records permanently to the table.



If the user has chosen the “Copy From” button to create a new table, the system will allow the choice of any current table.




Once a Language Table has been established, the user can also use the “Create Template” button to make the new table a template.

Starting with version 5.00, due to a change with the way Crystal Reports are handled, Multi-Language has been changed to give the user the ability to generate Translated Crystal Reports 1) at the creation of a new Language table, 2) after changes to an established Language table, 3) as well as on demand from the Multi-Language menu item.

After the Language Table has been completed or changed, the user will be asked the following:




This message will appear as the reports are generated indicating the percentage of completion. Note, this may take a couple of minutes.



Changing the Language Table


All text on the Translation side Language Table grid can be maintained.

There is a Find/Next search feature at the bottom of the table that can be used to search for specific words on the Origin or Translation side of the grid. The user can then easily change the desired text.




The buttons on the right side of the panel can also be used to:

Delete a Row.




Copy Origin Text to the Translation side of the grid.






User Maintenance

Each User Code can be assigned a different Language Code; if nothing is assigned, the user will continue to see everything in Standard Sage 100 English. To assign a Language Code to a user, choose the User Maintenance menu item.

Enter a User Code or use the Lookup to choose one on file.



Enter a Language Code or use the Lookup to choose one on file.




Once the entry is accepted and the User Code has been changed in Sage 100, the user will see the language changes take effect.

Message Maintenance

Larger text messages have been kept separate from the main Language Code translations and can be maintained through Message Maintenance.

See **Language Maintenance** on page 11 for information on creating/maintaining message text for Language Codes.




As in Language Maintenance, various buttons exist on the right side of the grid to aid in maintaining language translations - the user can use a Find/Replace Search function, Add/Delete rows in the grid, and replace a translation with the text from the Origin column if needed.

Miscellaneous Maintenance

If the user needs to add text not found by the English Language Builder, it must be added through this menu option.

Enter or select the desired Language Code:




Add the English text to the Origin side of the grid, and the translated text to the Translation side.


After the entries are accepted, they will be added to and appear on the appropriate Language table.

Report Generator


This menu option allows the user the ability to generate Translated Crystal Reports on demand for a specified Language Code.



Enter or choose the desired Language code from the Lookup and push Proceed.





Section E: Uninstall DSD Enhancements

A DSD Enhancements Uninstall Utility has been provided for the purposes of removing DSD Enhancements from your Sage 100 System. This utility may be accessed from the **DSD Enhancement Control Panel** menu option on the **Library Master / Utilities** menu.



 Select **Yes** to continue with the Uninstall Process.


The following message box will appear, to remind you that a complete backup of your entire Sage 100 system should be completed prior to uninstalling a DSD product.

After the Uninstall of the DSD Enhancement, you MUST reinstall certain standard Sage 100 modules, followed by reinstallation of Sage 100 Service Packs / Updates, if applicable.

The following message box will appear, and will display which of those specific Sage 100 modules you must reinstall afterwards.




The following message box will appear, displaying the final warning message.

- Reinstall any other DSD Enhancements or Developer products that are affected from the reinstallation of the standard Sage 100 module(s).


