### **Multi-Currency USD Demo Data Features**

The **Multi-Currency Demo Data** enables the **Sage 100** reseller the ability to effectively demonstrate the features of DSD's Multi-Currency enhancement to an end-user. Demo data has been created for the **ABC Company Code** for all distribution modules with the U.S. Dollar as the Base Currency Code.

## Section B: Getting Started

### CAUTION

- **If you reinstall or upgrade one of the Sage 100 modules listed in the following table, you must also reinstall this Enhancement.**
- Enhancements from different Sage Developers are generally not designed to work together. If installed together, problems are likely to occur.
- **Check with DSD before installing more than one Enhancement.**

### Installation

1. **Back-up:** Exit all Sage 100 sessions. Back-up existing Sage 100 data.
2. **Check Levels:** Sage 100 module levels **must match** those listed above.
3. **Run Enhancement Setup Program:** Save the executable installation program (sent to you or downloaded from our website) in a convenient location on the Sage 100 server. Launch the program from Windows Explorer or by selecting Start/Run, and then browse for the file in the location you saved it. Follow on-screen instructions.
4. **Send your Sage Serial Number to your DSD Representative:** Send your Sage Serial Number to your DSD representative in order for us to send you back the encrypted keys to unlock your system. This serial number can be found in Library Master\Setup\System Configuration, Tab 3. Registration as Serial Number.
5. **Re-Start Sage 100:** Sage 100 will be updated.
6. **Unlock the Enhancement:** DSD Enhancements must be unlocked to run. When any part of the Enhancement is run for the first time, the **DSD Enhancement License Agreement and Activation** window will appear. Follow the steps shown on that window. *You can click the Help button for more detailed instructions.*

**Note:** On the next page is a screenshot of the DSD Enhancement License Agreement and Activation window.



After accepting the License Agreement, you can then select the type of unlocking that you'd prefer. The choices are File, Web, Demo and Manual Entry.

**File Unlock:** After receiving your encrypted serial number key file from DSD, and placing that file in the MAS90/SOA directory, selecting this option will unlock all products keys contained in the file. This means you can unlock all enhancements at once using this option.

**Web Unlock:** If the system that is running the DSD Enhancement *has web access* and you *have sent DSD your Sage Serial number*, you can unlock the Enhancement without assistance using Web Unlock. When this option is selected, the program will attempt to download encrypted serial number key file from DSD *and then proceed to unlock all enhancements contained in the file.*

- *The Sage 100 system that is being used must have web access for this option to be effective.*
- *You can send your Sage Serial Number to your DSD Enhancements sales representative.*

**Demo Unlock:** If a Demo mode is available for the Enhancement you're running, you will be able to Demo unlock the product without assistance from DSD for demo purposes.

- *Creating a Demo Unlock is a good way to temporarily unlock DSD Enhancements off-hours, if you do not have web or email access. Later, you can unlock the product fully, during business hours.*

**Manual Entry Unlock:** If you want to unlock a single enhancement using a single encrypted key, you can select this option and enter the 64 character key you receive from DSD by copy and paste.

**Note:** *You can also unlock a DSD Enhancement through the **DSD Enhancement Control Panel** found on the Library Master Utilities Menu. Then, select the Enhancement with your mouse from the list of Enhancements and click the **Unlock Product** button on the right side of the window.*

- Convert Data:** After registration, the Data Conversion window will appear. Follow on-screen instructions to complete data conversion. *You can exit the conversion program without converting data. The Enhancement will not proceed, however, until data is converted. If you enter an enhanced program and data has not been converted, the conversion program will run again.*

### DSD Enhancement Control Panel

Starting with version 3.61, all DSD Enhancement products include DSD's Enhancement Control Panel. The **DSD Enhancement Control Panel is accessed from the Library Master Utilities menu.**

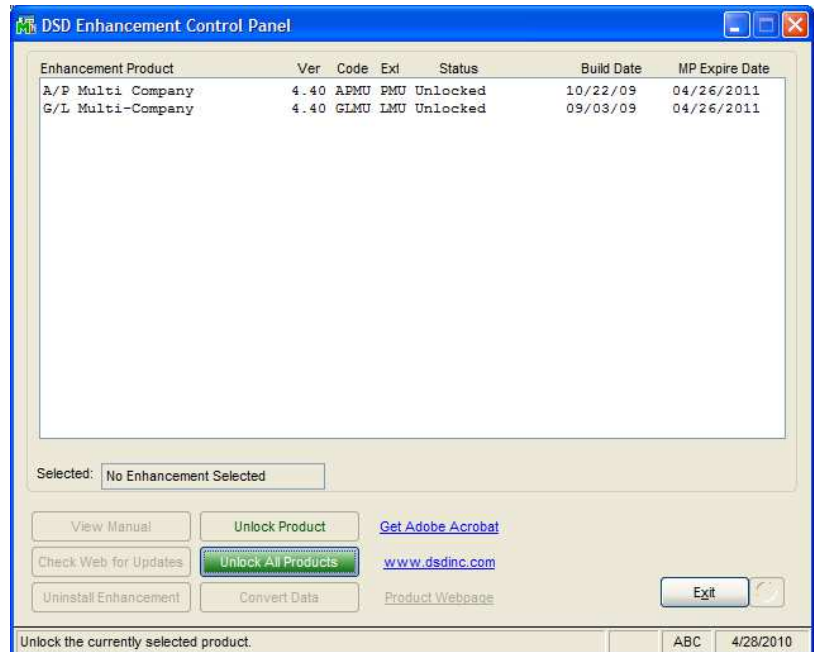
The DSD Enhancement Control Panel is a simple to use yet powerful system to help maintain DSD Enhancements installed on a Sage 100 system. To use it, select an Enhancement product from the list on the window and then click the button, on the right side of the window, which corresponds with the desired task.

**View Manual:** This button will display the product manual for the selected Enhancement using Adobe Acrobat. For this to be possible, the PDF file for the corresponding manual must be in the "MAS90/PDF" folder in the Sage 100 system. If the file is not present, and the system has web access, the correct PDF file will be automatically downloaded from the DSD website, put into the "MAS90/PDF" folder and then displayed.

**Check the Web for Updates:** This button will check the DSD website to see what the current build is the selected Enhancement and alert the user if a later version is available. *This requires an FTP web connection on the Sage 100 system.*

**Unlock Product:** This will cause the DSD Enhancement License Agreement and Activation window to appear. Using this window is described on the previous page. *This button is disabled if the selected Enhancement is already unlocked.*

**Unlock All Products:** This will cause the DSD Enhancement All License Agreement and Activation window to appear. This window is similar to the one described on the previous page, but has only web and file as options to unlock. *This button is never disabled.*



**Convert Data:** After verification, the selected Enhancements data conversion program will run. Data conversion is non-destructive, and may be triggered any number of times. Sometimes this is required to fix data records imported or updated from a non-enhancement installation.

**Help:** The Help button, located at the bottom right of the window, opens an HTML help file .

**Get Adobe Acrobat:** Opens the Adobe Acrobat website to the page where Acrobat can be downloaded and installed.

**Uninstall Enhancement** If this option is available, then selecting this button will start the un-install process, removing the enhancement from the system.

There are also links to the DSD website and the Enhancement page on that site.

## Section C: Setup

### FASB 52

When setting up company information for a Multi-Currency System, there are 2 categories:

- (1) Those companies that require FASB 52-compliant data, and
- (2) Those companies that **DO NOT** require FASB 52-compliant data.

The DSD Multi-Currency Demo Data falls under category 2, in that there is no FASB 52-related information setup in the ABC Demo Data company. If you need assistance in setting up the FASB-52 data for demonstration purposes, please refer to the G/L Multi-Currency (GLMC) manual, or contact the Multi-Currency Product Manager at DSD Business Systems.

### C/U Multi-Currency Module

On the Multi-Currency Main Menu, there are 3 maintenance/setup programs: Multi-Currency Options, Currency Code Maintenance, and Foreign Price/Cost Maintenance.

#### Multi-Currency Options

This is the starting point in setting up the Currency Module.

As you can see, the Multi-Currency Module has been enabled, and the Base Currency Code has been set here, to USD (US Dollar). There is no Multi-Currency Supervisor password set up (you can set one up if you'd like), and the Default Currency for Reports is set to Entry Currency. You can change this if you want the reports to default to Base Currency (USD in this case).

Three new G/L accounts have been set up in G/L Account Maintenance:

Currency Gain/Loss	970-00-XX (by Division)
Currency Roundoff	970-00-00
Currency Roundoff for Reporting	315-00-00

The **Currency Gain/ Loss** and **Roundoff** accounts are used in A/P and A/R Division Maintenance. The **Currency Roundoff** account is also used in General Journal Entry and Transaction Entry (if GLMC is installed). The last account, **Currency Roundoff for Reporting**, is used for Roundoff when printing G/L reports and financials.

The **FASB 52 Tab** in Multi-Currency Options is where you setup the FASB 52 Currency, if applicable.

The **Integrate Tab** shows which Multi-Currency Modules are installed. In this version, the flags may not be changed.

### ***Currency Code Maintenance***

There are several currency codes set up in Currency Code Maintenance. The U.S. Dollar (USD) has been selected as Base Currency (also referred to as Primary or Functional Currency). Here are the five currencies:

There are many web sites available that list current exchange rates, such as [www.oanda.com](http://www.oanda.com).

On the Exchange Rates Panel, there are a few nice features you may want to point out, such as the "Today" button and the "Description Toggle" button.

You'll also notice that there are four different exchange rates that you can setup per day: AR/SO Rate, AP/PO Rate, GL Rate, and FASB 52 Rate. Most companies only use one exchange rate, so when you enter the AR/SO Rate, the program automatically defaults the other three exchange rates to that rate.


You may select the Printer Button to print a Currency Code Listing.

### Inventory Multicurrency Module (IMMC), Foreign Price/Cost Maintenance

#### Foreign Price/Cost Maintenance

**Note:** This program is only available if IMMC has been installed and setup.

Several entries have been created in Foreign Price/Cost Maintenance. These prices and costs will be reflected when doing data entry in Sales Order and Purchase Order.

### Multicurrency Reports Menu

The following reports are available from the Multi-Currency Reports Menu:

**Currency Code Listing:** This lists the Currency Code information and Exchange Rates.

**Currency Audit Report:** This is a Masterfile Audit listing

**A/P Unrealized Gain/Loss Report:** This is only available if you have APMC Installed, and prints what the Realized Gain/Loss would be if all open A/P Invoices were paid as of a certain date. Users can use this report to post unrealized gain/loss.

**A/R Unrealized Gain/Loss Report:** This is only available if you have ARMC Installed, and prints what the Realized Gain/Loss would be if all open A/R Invoices were paid as of a certain date. Users can use this report to post unrealized gain/loss.

**Foreign Price/Cost Listing:** This is only available if you have IMMC Installed, and prints the information entered in Foreign Price/Cost Maintenance.

**Foreign Price/Cost Listing:** This is only available if you have IMMC Installed, and prints the information entered in Inventory Maintenance for Foreign Price/Cost breaks.

## Section D: System Operations

### General Ledger

The Demo Data provided only has the three new GL Accounts setup. Many accounts will show the Multicurrency G/L Detail Information in the Transactions Tab.

### Bank Reconciliation

There are only two places in the B/R module that need demonstrating: Bank Code Maintenance and Check, Deposit, & Adjustment Entry. No Multi-Currency Data has been posted to the Check, Deposit, & Adjustment Entry in this release of MCDD.

### Bank Code Maintenance

There are several new Bank Codes that have been added for foreign bank accounts.

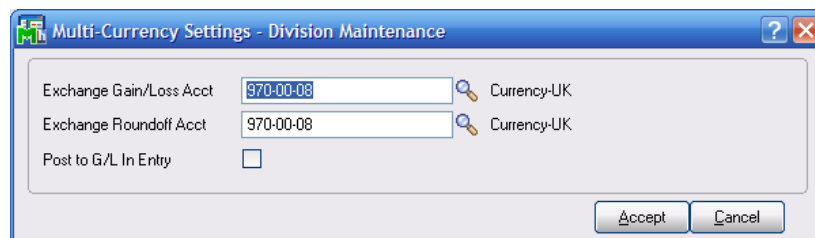
Select the **Currency Button** to display the Currency Code of each Bank Code.

### Accounts Payable

There are two places in A/P Setup to demonstrate: Division Maintenance and Bank Code Maintenance. Please refer to the B/R module for a description on the Bank Code Demo Data.

### Division Maintenance

Several new Divisions have been added to the Division Masterfile for Multi-Currency vendors. New accounts have been set up in Division Maintenance for all divisions. Select the **Currency Button** to access these accounts:



### Vendor Maintenance / Inquiry

There are several new vendors set up in Vendor Maintenance. There are also a number of transactions, such as invoice history, check history, and purchase orders set up for all of these vendors.

When demonstrating Vendor Maintenance to an end-user, show off these features:

- 1) Main Panel – **Currency Button** – set up of Currency Codes
- 2) Statistics Panel – **Amounts In Toggle Button**
  - toggle between Historical Currency and Base Currency.
- 3) Summary Panel – **Amounts In Toggle Button**
  - toggle between Historical Currency and Base Currency.
- 4) History Panel – **Amounts In Toggle Button**
  - toggle between Historical Currency and Base Currency.
- 5) Invoices Panel – **Amounts In Toggle Button**
  - toggle between Historical, Base, and Transaction Currency.
- 6) Transactions Panel – **Amounts In Toggle Button**
  - toggle between Historical, Base, and Transaction Currency.
- 7) Checks Panel – **Amounts In Toggle Button**
  - toggle between Historical, Base, and Transaction Currency.
- 8) P/O's Panel – **Amounts In Toggle Button**
  - toggle between Historical, Base, and Transaction Currency.
- 9) **Drill Down!**
  - drill down from Invoices, Checks, and P/O's panel.

### **Data Entry**

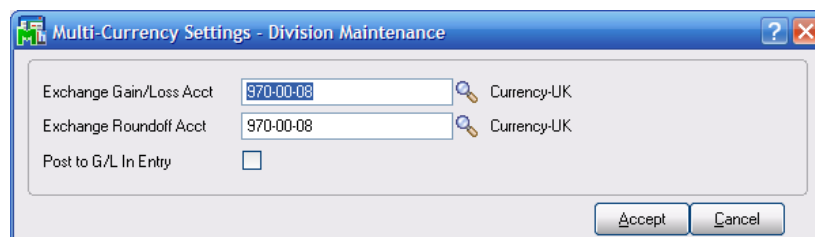
Of course you'll want to demonstrate Invoice Data Entry, Manual Check Entry, and Check Entry to the end-user. Use the foreign vendors in your demonstration and show how it defaults to the currency and exchange rate, and how you can override these settings.

### **Accounts Receivable**

There are two places in A/R Setup to demonstrate: Division Maintenance and Bank Code Maintenance. Please refer to the B/R module for a description on the Bank Code Demo Data.

### **Division Maintenance**

Several Divisions have been added to the Division Masterfile for Multi-Currency customers. New accounts have been set up in Division Maintenance for all divisions. Select the **Currency Button** to access these accounts:





### Customer Maintenance / Inquiry

There are several new customers set up in Customer Maintenance. There are also a number of transactions, such as invoice history and sales orders set up for all of these customers.

When demonstrating Customer Maintenance to an end-user, show off these features:

- 1) Main Panel – **Currency Button** – set up of Currency Codes
- 2) Statistics Panel – **Amounts In Toggle Button**
  - toggle between Historical Currency and Base Currency.
- 3) Summary Panel – **Amounts In Toggle Button**
  - toggle between Historical Currency and Base Currency.
- 4) History Panel – **Amounts In Toggle Button**
  - toggle between Historical Currency and Base Currency.
- 5) Invoices Panel – **Amounts In Toggle Button**
  - toggle between Historical, Base, and Transaction Currency.
- 6) Transactions Panel – **Amounts In Toggle Button**
  - toggle between Historical, Base, and Transaction Currency.
- 7) S/O's Panel – **Amounts In Toggle Button**
  - toggle between Historical, Base, and Transaction Currency.
- 8) **Drill Down!** - drill down from Invoices and S/O's panel.

### Data Entry

Of course you'll want to demonstrate Invoice Data Entry, Repetitive Invoice Entry, and Cash Receipts Entry to the end-user. Use the foreign customers in your demonstration and show how it defaults to the currency and exchange rate, and how you can override these settings.

## Inventory Management

### Foreign Price/Cost Maintenance

The Foreign Price/Cost Maintenance is accessible from the Multi-Currency Main Menu.

### Inventory Maintenance

If you have Foreign Price/Costs setup, then you can do Foreign Price Breaks off of the Foreign Price. Select the Pricing Button from the Inventory Maintenance Main Panel and change the currency of the price break. Note that the Foreign Price/Cost is displayed, and that all breaks can work off of that foreign price/cost.

**Purchase Order**

Several purchase orders have been created for foreign Vendors:

You may use these purchase orders for demonstration purposes, or you may create new ones for the three new vendors. You may also drill down to these PO's from Vendor Maintenance or Item Maintenance.

**Sales Order**

Several sales orders have been created for foreign Customers.

You may use these sales orders for demonstration purposes, or you may create new ones for the three new customers. You may also drill down to these orders from Customer Maintenance or Item Maintenance.

**Additional features**

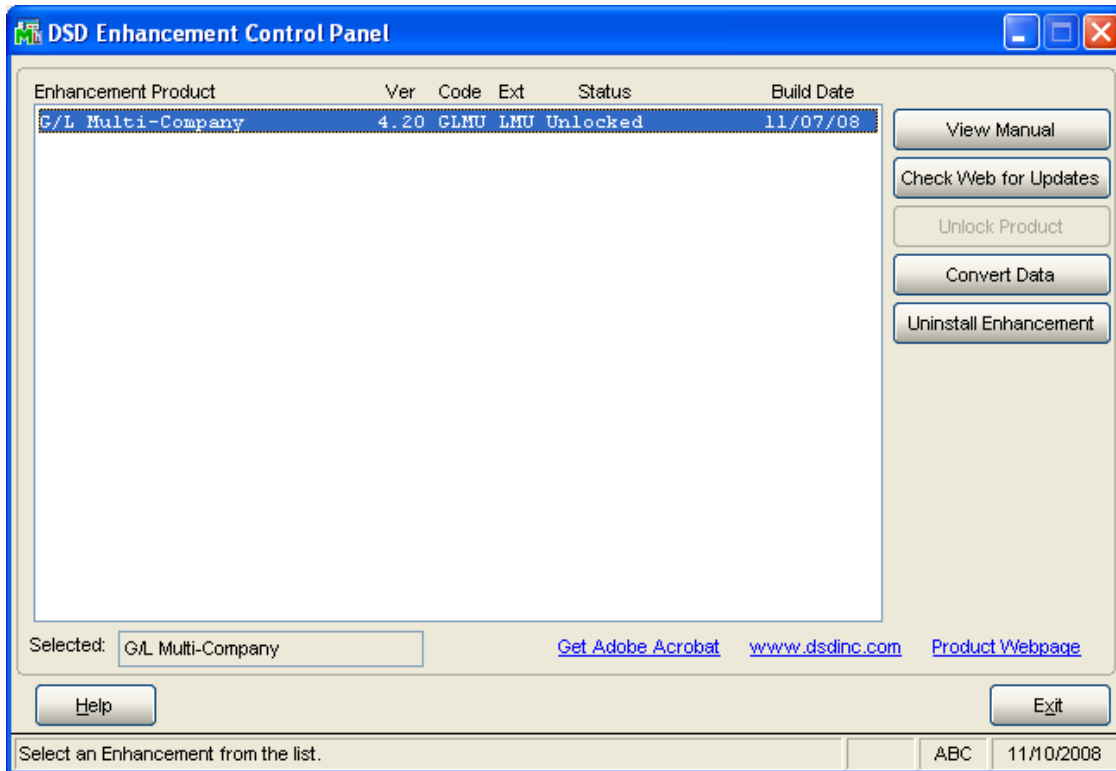
In addition to the features listed in this manual, you may want to show off:

2. Reporting – Currency Pop-up panel allows currency selection.

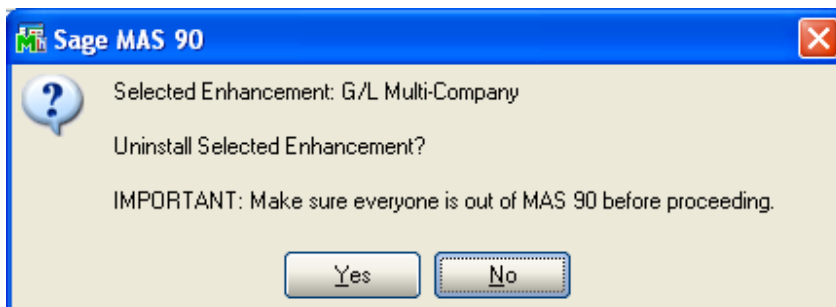

## Section E: Uninstall DSD Enhancements

A DSD Enhancements Uninstall Utility has been provided for the purposes of removing DSD Enhancements from your Sage 100 System. This utility may be accessed from the **DSD Enhancement Control Panel** menu option on the **Library Master / Utilities** menu.

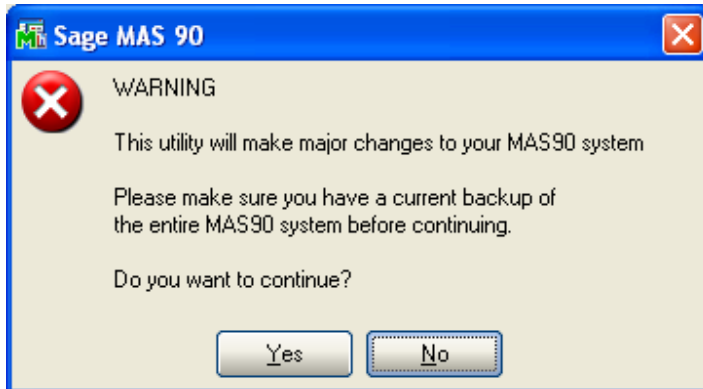


When accessing the **DSD Utility Suite**, select the enhancement that you wish to Uninstall, and then select the **Uninstall Enhancement** button. The following message box will appear:

 Select **Yes** to continue with the Uninstall Process.

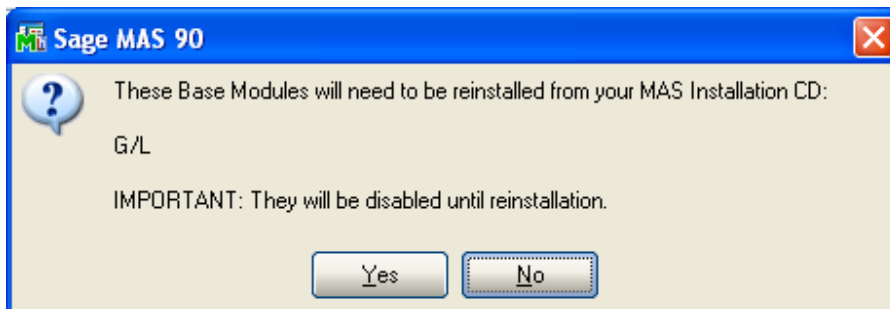
The following message box will appear, to remind you that a complete backup of your entire Sage 100 system should be completed prior to uninstalling a DSD product.



Select **No** to exit the Uninstall Process.  
Select **Yes** to continue with the Uninstall Process.

**After the Uninstall of the DSD Enhancement, you MUST reinstall certain standard Sage 100 modules, followed by reinstallation of MAS Service Packs / Updates, if applicable.**

The following message box will appear, and will display which of those specific Sage 100 modules you must reinstall afterwards.

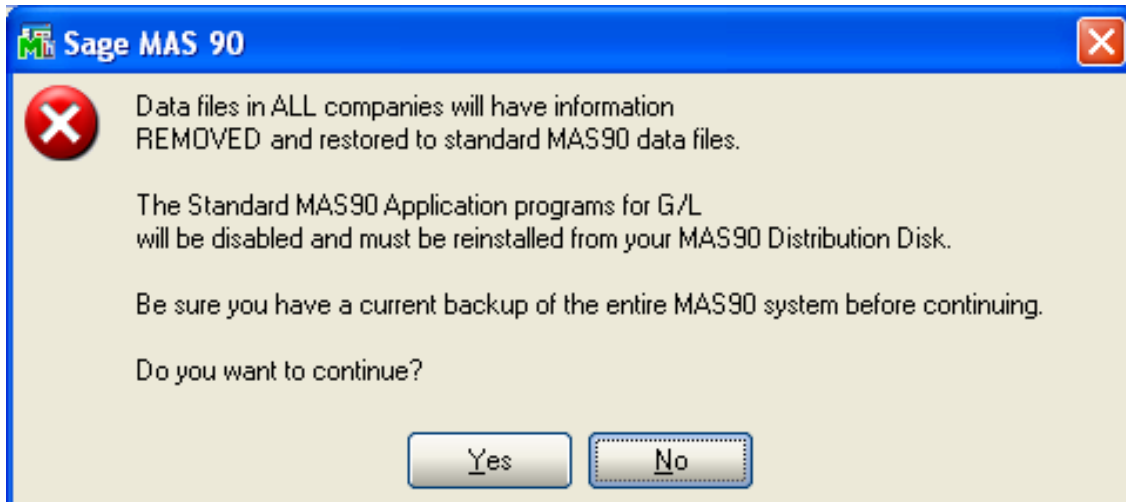


Select **No** to exit the Uninstall Process.  
Select **Yes** to continue with the Uninstall Process.

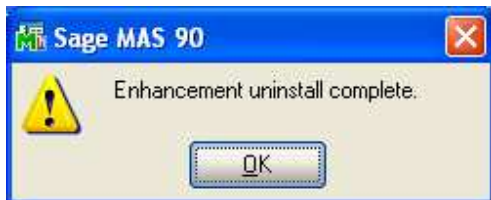
The following message box will appear, displaying the final warning message.

Select **Yes** to continue with the Uninstall Process. At this point, the DSD Enhancement will be removed from the Sage 100 system.

Now that the Uninstall process is completed, you must:

- Reinstall the applicable standard Sage 100 modules
- Reinstall the latest Sage 100 Service Pack/Updates, if applicable.
