### ***Receipt of Goods Import Utility Features***

This DSD Extended Solution utility imports data from a file into the Purchase Order Receipt of Goods file. Multiple import formats are supported; please refer the appendices at the end of this document for format specifications. Additionally, a non graphical 'Bar Code Receiver Form' has been added.

Additional functionality exists if the Custom Office module is activated or if Extended Solution CM-1003: *User Defined Fields for Lot/Serial Numbers* is installed.

In order to use the Excel format, Microsoft Excel must be installed on the workstation running the import.

## Section B: Getting Started



- **If you reinstall or upgrade one of the Sage 100 modules listed in the following table, you must also reinstall this Enhancement.**
- Enhancements from different Sage Developers are generally not designed to work together. If installed together, problems are likely to occur.
- **Check with DSD before installing more than one Enhancement.**

### Required Levels

### Installation

1. **Back-up:** Exit all Sage 100 sessions. Back-up existing Sage 100 data.
2. **Check Levels:** Sage 100 module levels **must match** those listed above.
3. **Run Enhancement Setup Program:** Save the executable installation program (sent to you or downloaded from our website) in a convenient location on the Sage 100 server. Launch the program from Windows Explorer or by selecting Start/Run, and then browse for the file in the location you saved it. Follow on-screen instructions.
4. **Send your Sage Serial Number to your DSD Representative:** Send your Sage Serial Number to your DSD representative in order for us to send you back the encrypted keys to unlock your system. This serial number can be found in Library Master\Setup\System Configuration, Tab 3. Registration as Serial Number.
5. **Re-Start Sage 100:** Sage 100 will be updated.
6. **Unlock the Enhancement:** DSD Enhancements must be unlocked to run. When any part of the Enhancement is run for the first time, the **DSD Enhancement License Agreement and Activation** window will appear. Follow the steps shown on that window. *You can click the Help button for more detailed instructions.*

**Note:** On the next page is a screenshot of the DSD Enhancement License Agreement and Activation window.

After accepting the License Agreement, you can then select the type of unlocking that you'd prefer. The choices are File, Web, Demo and Manual Entry.

**File Unlock:** After receiving your encrypted serial number key file from DSD, and placing that file in the MAS90/SOA directory, selecting this option will unlock all products keys contained in the file. This means you can unlock all enhancements at once using this option.

**Web Unlock:** If the system that is running the DSD Enhancement *has web access* and you *have sent DSD your Sage Serial number*, you can unlock the Enhancement without assistance using Web Unlock. When this option is selected, the program will attempt to download encrypted serial number key file from DSD and then proceed to unlock all enhancements contained in the file.

- The Sage 100 system that is being used must have web access for this option to be effective.
- You can send your Sage Serial Number to your DSD Enhancements sales representative.

**Demo Unlock:** If a Demo mode is available for the Enhancement you're running, you will be able to Demo unlock the product without assistance from DSD for demo purposes.

- Creating a Demo Unlock is a good way to temporarily unlock DSD Enhancements off-hours, if you do not have web or email access. Later, you can unlock the product fully, during business hours.

**Manual Entry Unlock:** If you want to unlock a single enhancement using a single encrypted key, you can select this option and enter the 64 character key you receive from DSD by copy and paste.

**Note:** You can also unlock a DSD Enhancement through the [DSD Enhancement Control Panel](#) found on the Library Master Utilities Menu. Then, select the Enhancement with your mouse from the list of Enhancements and click the **Unlock Product** button on the right side of the window.

- Convert Data:** After unlocking, the DSD Conversion Wizard will appear. Follow on-screen instructions to complete data conversion. You can exit the conversion program without converting data. The Enhancement will not proceed, however, until data is converted. If you enter an enhanced program and data has not been converted, the conversion program will run again.

### DSD Enhancement Control Panel

Starting with version 3.61, all DSD Enhancement products include DSD's Enhancement Control Panel. The **DSD Enhancement Control Panel is accessed from the Library Master Utilities menu.**

The DSD Enhancement Control Panel is a simple to use yet powerful system to help maintain DSD Enhancements installed on a Sage 100 system. To use it, select an Enhancement product from the list on the window and then click the button, on the right side of the window, which corresponds with the desired task.

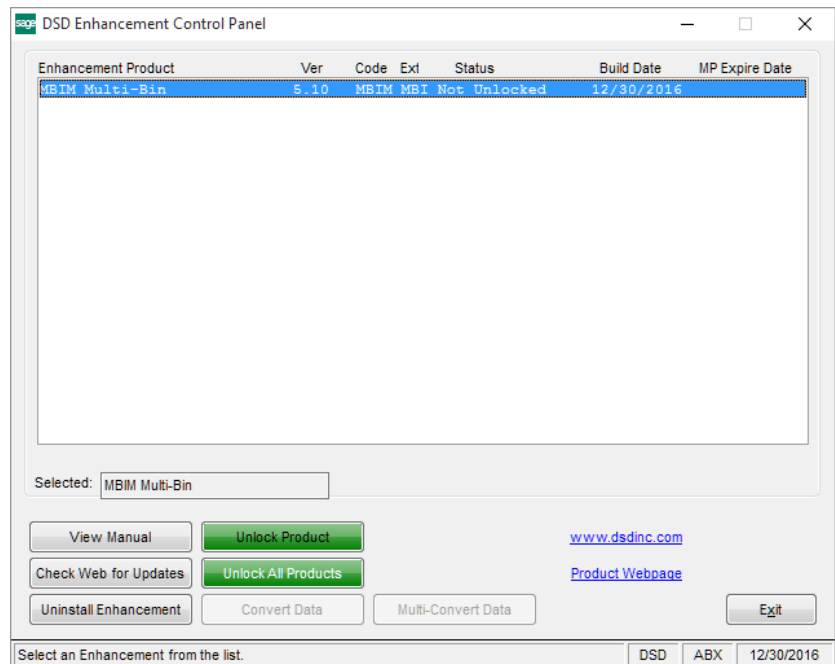
**View Manual:** This button will display the product manual for the selected Enhancement using Adobe Acrobat. For this to be possible, the PDF file for the corresponding manual must be in the "MAS90/PDF" folder in the Sage 100 system. If the file is not present, and the system has web access, the correct PDF file will be automatically downloaded from the DSD website, put into the "MAS90/PDF" folder and then displayed.

**Check the Web for Updates:** This button will check the DSD website to see what the current build is the selected Enhancement and alert the user if a later version is available. *This requires an internet connection on the Sage 100 system.*

**Unlock Product:** This will cause the DSD Enhancement License Agreement and Activation window to appear. Using this window is described on the previous page. *This button is disabled if the selected Enhancement is already unlocked or if unlocking is not required.*

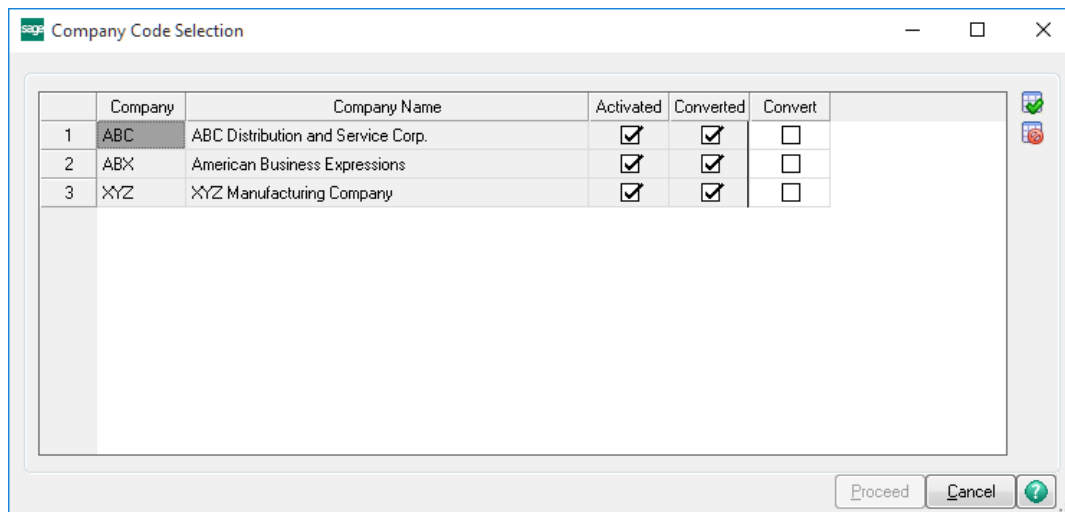
**Unlock All Products:** This will cause the DSD Enhancement All License Agreement and Activation window to appear. This window is similar to the one described on the previous page, but has only web and file as options to unlock. *This button is never disabled.*

**Convert Data:** After verification, the selected Enhancement's data conversion program will run. Data conversion is non-destructive, and may be triggered any number of times. Sometimes this is required to fix data records imported or updated from a non-enhancement installation.





**Multi-Convert Data:** Multiple Companies can be converted at the same time for a given Enhancement. *(If you have a large number of Companies to convert, please do in batches of 20 or fewer due to memory limitations.)*



**Help:** The Help button, located at the bottom right of the window, opens an HTML help file.

**Get Adobe Acrobat:** Opens the Adobe Acrobat website to the page where Acrobat can be downloaded and installed.

**Uninstall Enhancement** If this option is available, then selecting this button will start the un-install process, removing the enhancement from the system. (for more information see [Uninstall DSD Enhancements](#))

## Section C: Setup

Upon completion of software installation, you will need to access the DSD Extended Solutions Setup from the Purchase Order Setup menu. Select this part number and the Setup screen for this Extended Solution will appear. Check the 'Enable DSD Extended Solution' box to activate this Extended Solution.

Answer the following prompts on the Setup tab:

**Import File Format:** Select Standard, Hilo, Invoice, Excel, Agenet or Bar Code.

**Default Import Path:** Enter the default import file path.

**Default Import Filename:** Enter the default file name.

**Delete File After Import:** Check this box if you wish to delete the import file after the import takes place. Leave it blank if you wish to retain the import file after the import.

**Rename File Extension:** If you retain old import files, enter a new extension for the file.

**Purchase Order Barcode Printing Form Code:** Enter a Form Code if you wish to add 'Bar Code receiver Form Printing' to the main menu.

**Private Batch:** Select this checkbox to make the Receipt Batch private to the user running the import.

The following option is available only if you are using the Standard format.

**Use The Alternate Eprom Format:** Check this box to use the alternate EPROM format. This format starts the Serial Number field at position 56. This prompt defaults to 'N' which sets the Serial Number field at position 59.

The following options are available only if you are using the Invoice format.

**Import P/O Header Custom Office UDFs:** Check this box to Import P/O Header Custom Office UDFs.

**Purchase Order Header UDF for 'Ship Via':** Specify the 15 character string P/O Header UDF that will receive a ship via data from the import file.

The following options are available only if you are using the AgeNet format.

**P/O ROG Line UDF for 'Imported Unit Cost':** Specify the 10 character maximum length numeric P/O ROG Line UDF that will receive the Unit Cost field from the import file.

**Miscellaneous Charge for Imported Tax:** Enter a P/O Miscellaneous Charge code that will be added to the Receipt having the value of the import file's Tax Field.

If you have selected the 'Standard' format you will have access to this option, it is not required:

**Lot/Serial UDF For 'Standard' Format:** Specify the 6 character string or numeric UDF which will be included in the import file.

If you have selected the Excel format, then specify all of the remaining UDFs (see the Appendix for information on types and lengths)

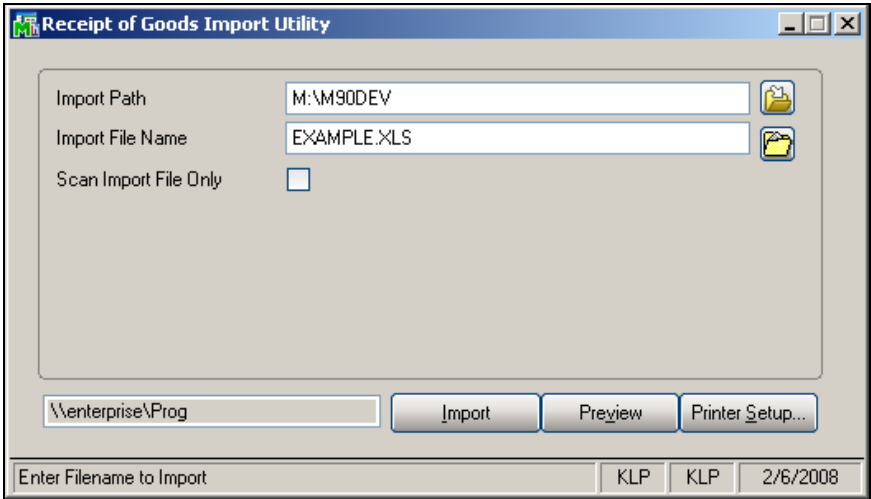

Section D: System Operations

The Purchase Order ROG Import Utility can be found on the Setup menu. When accessed, you will be prompted for the Import Path and Filename. These default from what was specified in Setup but can be overridden.



An additional option is provided to Scan the Import file without performing the actual import process. This will allow the user to view an error report of all invalid records before importing the file. The errors that are reported relate to fields within the import record which are unrecognizable, invalid or improper. This error report is generated during the import process as well.

Click the Import button to transfer all validated records to the P/O Receipt of Goods data file.

This utility does not support multiple lines with the same item; it will receive only against the first line it encounters. Be sure that the P/O does not list an item more than once.

**Hilo Format**

In this format, a Receipt Number will be imported. If the Receipt Number already exists in the data entry batch, then the imported lines will be appended to it. A record will not be imported if:

- A Receipt Number and Vendor Number combination already exists in the P/O Receipt of Goods History file
- A Receipt Number exists in the data entry batch.

Prepaid freight will be imported if the Invoice Number being imported does not already exist in the A/P open invoice file for this vendor.

See the Appendix for the file layout.

**Excel Format**

***The described feature was developed for a specific client to its specifications and may not conform to generally accepted Sage 100 standards and procedures. These features may or may not benefit you in your application of Sage 100.***

All worksheets are considered one import file. The same Purchase Order Number can be referenced on multiple worksheets; therefore, one Receipt of Goods transaction per Purchase Order Number will be created and referenced across all worksheets. For all worksheets, the data will always begin in Column A and on Row 3. Data in rows one and two will be ignored. The Quantity Received will be the sum of all rows in which the 'Part Number'/'Ref #' combination are the same. All items to be imported are of a Serialized Valuation method.

If the valid I/M Item Number Serial valuation doesn't exist on the Purchase Order, it will be added as a new line to the Receipt of Goods. All rules of consolidation outlined above (the Quantity Received will be the sum of all rows in which the 'Part Number'/'Ref #' combination are the same) still apply.

See the Appendix for the file layout and Format Codes.

**Invoice Format**

This format is designed to be used in conjunction with Extended Solution SO-1327, *Sales Order Invoice Export Utility*. If you checked the 'Import P/O Header Custom Office UDFs' option in Setup, and there are additional fields at the end of the import file, these fields will be imported into P/O Header UDFs.



**Non-Graphical Bar Coded Receiver Form**

This option has been added to the Main menu.

The 'Bar Coded Receiver Form Printing' dialog box contains the following elements:

The selection screen prompts for the Order Status and order Type(s) to include as well as a range of Purchase Order Numbers. You may also enter up to two lines of messages to print on the form.

Certain special characters, such as the '/', cannot be bar coded in Code 39 format. If you use many special characters when assigning Item Numbers, it may be preferable to use Code 128 format.

You can maintain the new form fields for this Extended Solution by clicking the 'Form...' button. A window will pop up where you may select the form you would like to maintain (Figure 6). Select this Extended Solution to display the Form Maintenance screen (Figure 7).

The standard form provides all of the fields that you have in P/O Printing. The PO-1034 form provides additional bar coded fields: Item Number, Quantity Ordered less Quantity Received, and P/O Number.

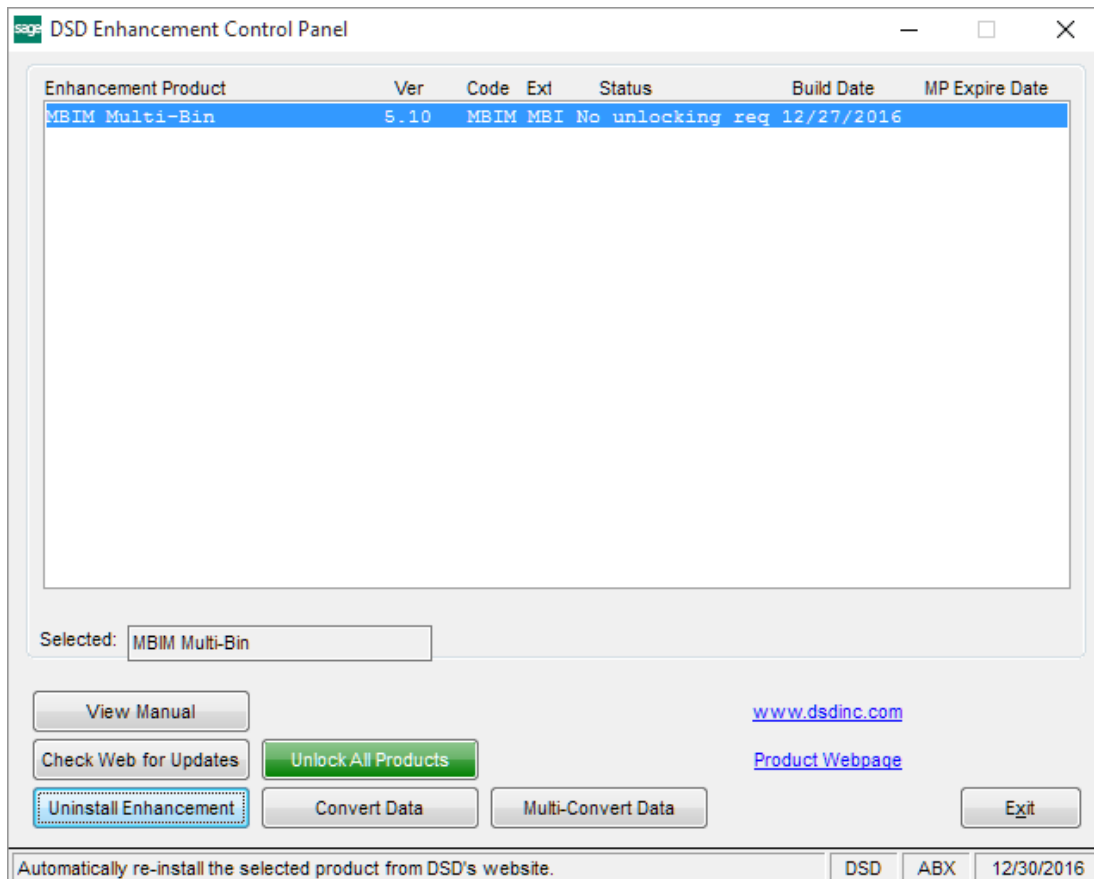

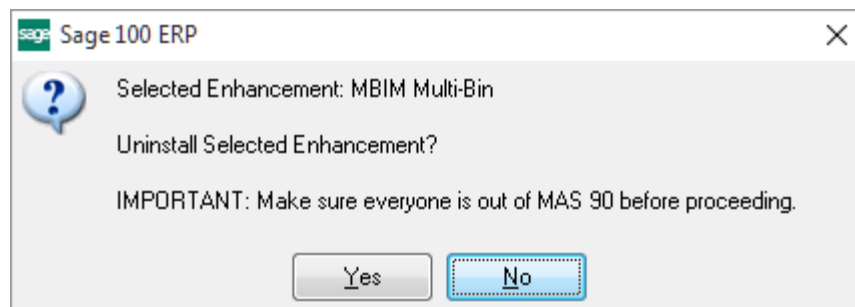

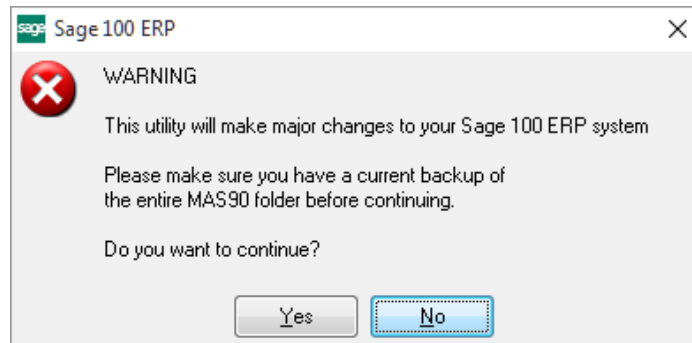

Select **Yes** to continue with the Uninstall Process.

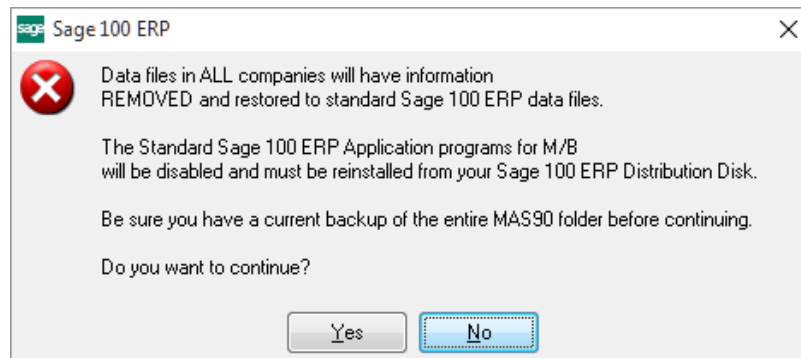

Select **Yes** to continue with the Uninstall Process.

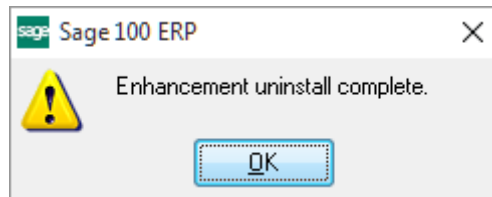
