MAS*Ship Features

MAS*Ship is a link for the Sales Order Module to integrate Sage 100 with UPS Worldship® or FedEx ShipManager® applications. Reduce shipping errors and know exactly when your orders have shipped. MAS*Ship provides a significant savings in data entry time.

KEY FEATURES

Easy to Use and Easy to Learn

Because you are still using the same program (UPS Worldship or FedEx Ship Manager) there are no new programs your warehouse users need to learn. However, with MAS*Ship UPS Worldship and FedEx Ship Manager can now integrate with Sage 100

Increased Accuracy

Connecting Sage 100 with UPS Worldship and FedEx Ship Manager will reduce data entry mistakes, increase shipping and invoicing efficiency and provide accurate up-to-date shipping information in MAS 90. Example in UPS Worldship, if an address is incorrect, UPS Worldship will automatically correct it and now with the MAS*Ship that address correction will also flow automatically thru to Sage 100 along with tracking numbers freight dollars and weight (freight dollars is an optional setting and not required).

Increased Efficiency

Instead of accounting re-entering information received from shipping, accounting now will just need to review the shipment batch, make corrections and print invoices. No more trying to decipher the cryptic notes and marks from shipping because now it is all kept in electronically in Sage 100 along with who processed the shipment.

Section B: Getting Started



- **If you reinstall or upgrade one of the Sage 100 modules listed in the following table, you must also reinstall this Enhancement.**
- Enhancements from different Sage Developers are generally not designed to work together. If installed together, problems are likely to occur.
- **Check with DSD before installing more than one Enhancement.**

Installation

1. **Back-up:** Exit all Sage 100 sessions. Back-up existing Sage 100 data.
2. **Check Levels:** Sage 100 module levels **must match** those listed above.
3. **Run Enhancement Setup Program:** Save the executable installation program (sent to you or downloaded from our website) in a convenient location on the Sage 100 server. Launch the program from Windows Explorer or by selecting Start/Run, and then browse for the file in the location you saved it. Follow on-screen instructions.
4. **Send your Sage Serial Number to your DSD Representative:** Send your Sage Serial Number to your DSD representative in order for us to send you back the encrypted keys to unlock your system. This serial number can be found in Library Master\Setup\System Configuration, Tab 3. Registration as Serial Number.
5. **Re-Start Sage 100:** Sage 100 will be updated.
6. **Unlock the Enhancement:** DSD Enhancements must be unlocked to run. When any part of the Enhancement is run for the first time, the **DSD Enhancement License Agreement and Activation** window will appear. Follow the steps shown on that window. *You can click the Help button for more detailed instructions.*

Note: On the next page is a screenshot of the DSD Enhancement License Agreement and Activation window.

After accepting the License Agreement, you can then select the type of unlocking that you'd prefer. The choices are File, Web, Demo and Manual Entry.

File Unlock: After receiving your encrypted serial number key file from DSD, and placing that file in the MAS90/SOA directory, selecting this option will unlock all products keys contained in the file. This means you can unlock all enhancements at once using this option.

Web Unlock: If the system that is running the DSD Enhancement *has web access* and you *have sent DSD your Sage Serial number*, you can unlock the Enhancement without assistance using Web Unlock. When this option is selected, the program will attempt to download encrypted serial number key file from DSD *and then proceed to unlock all enhancements contained in the file*.

- *The Sage 100 system that is being used must have web access for this option to be effective.*
- *You can send your Sage Serial Number to your DSD Enhancements sales representative.*

Demo Unlock: If a Demo mode is available for the Enhancement you're running, you will be able to Demo unlock the product without assistance from DSD for demo purposes.

- *Creating a Demo Unlock is a good way to temporarily unlock DSD Enhancements off-hours, if you do not have web or email access. Later, you can unlock the product fully, during business hours.*

Manual Entry Unlock: If you want to unlock a single enhancement using a single encrypted key, you can select this option and enter the 64 character key you receive from DSD by copy and paste.

Note: You can also unlock a DSD Enhancement through the [DSD Enhancement Control Panel](#) found on the Library Master Utilities Menu. Then, select the Enhancement with your mouse from the list of Enhancements and click the **Unlock Product** button on the right side of the window.

- Convert Data:** After unlocking, the DSD Conversion Wizard will appear. Follow on-screen instructions to complete data conversion. *You can exit the conversion program without converting data. The Enhancement will not proceed, however, until data is converted. If you enter an enhanced program and data has not been converted, the conversion program will run again.*

DSD Enhancement Control Panel

Starting with version 3.61, all DSD Enhancement products include DSD's Enhancement Control Panel. The **DSD Enhancement Control Panel is accessed from the Library Master Utilities menu.**

The DSD Enhancement Control Panel is a simple to use yet powerful system to help maintain DSD Enhancements installed on a Sage 100 system. To use it, select an Enhancement product from the list on the window and then click the button, on the right side of the window, which corresponds with the desired task.

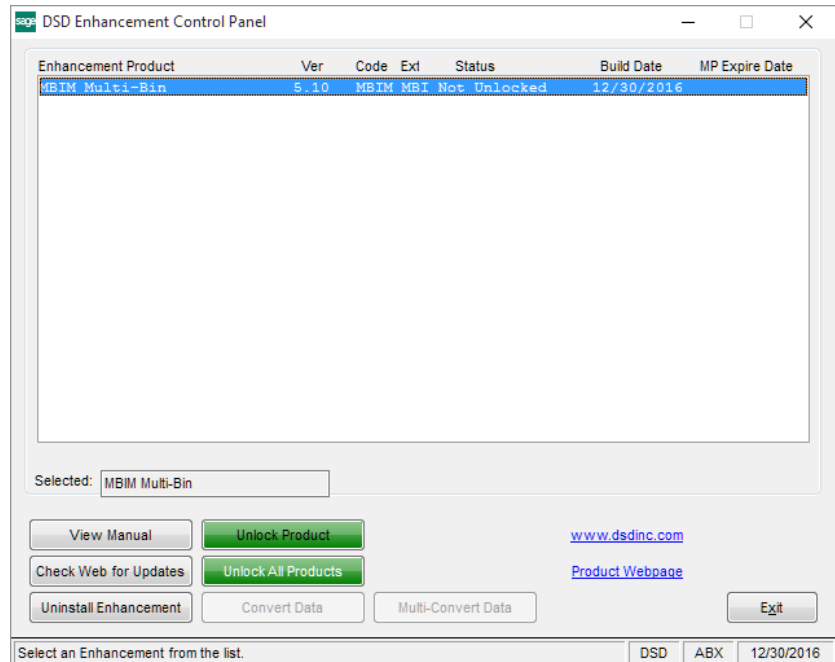
View Manual: This button will display the product manual for the selected Enhancement using Adobe Acrobat. For this to be possible, the PDF file for the corresponding manual must be in the "MAS90/PDF" folder in the Sage 100 system. If the file is not present, and the system has web access, the correct PDF file will be automatically downloaded from the DSD website, put into the "MAS90/PDF" folder and then displayed.

Check the Web for Updates: This button will check the DSD website to see what the current build is the selected Enhancement and alert the user if a later version is available. *This requires an internet connection on the Sage 100 system.*

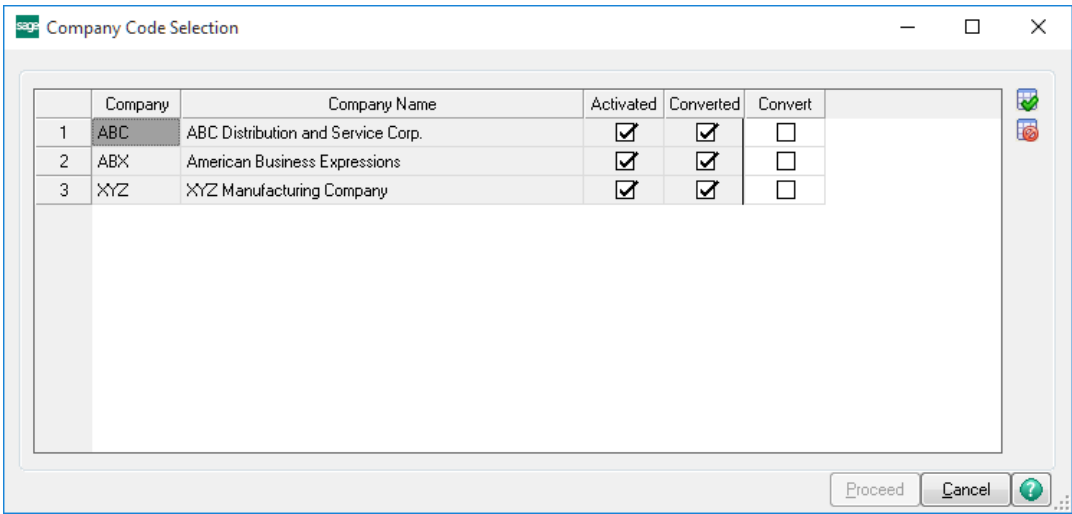
Unlock Product: This will cause the DSD Enhancement License Agreement and Activation window to appear. Using this window is described on the previous page. *This button is disabled if the selected Enhancement is already unlocked or if unlocking is not required.*

Unlock All Products: This will cause the DSD Enhancement All License Agreement and Activation window to appear. This window is similar to the one described on the previous page, but has only web and file as options to unlock. *This button is never disabled.*

Convert Data: After verification, the selected Enhancement's data conversion program will run. Data conversion is non-destructive, and may be triggered any number of times. Sometimes this is required to fix data records imported or updated from a non-enhancement installation.



Multi-Convert Data: Multiple Companies can be converted at the same time for a given Enhancement. *(If you have a large number of Companies to convert, please do in batches of 20 or fewer due to memory limitations.)*



Help: The Help button, located at the bottom right of the window, opens an HTML help file.

Get Adobe Acrobat: Opens the Adobe Acrobat website to the page where Acrobat can be downloaded and installed.

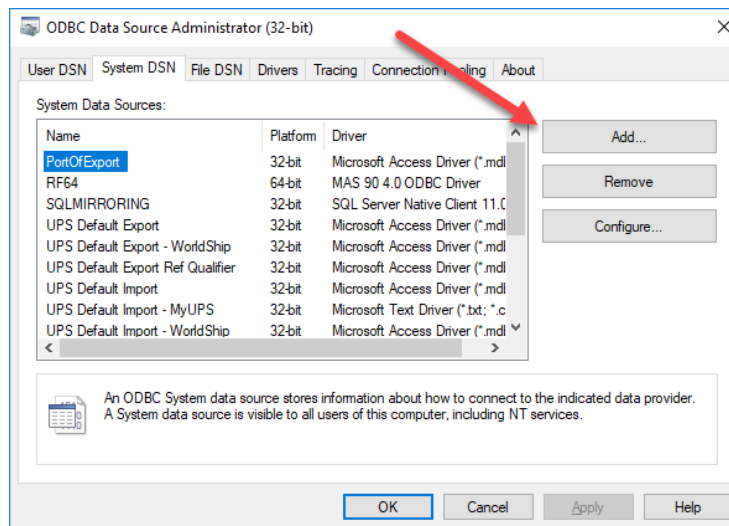

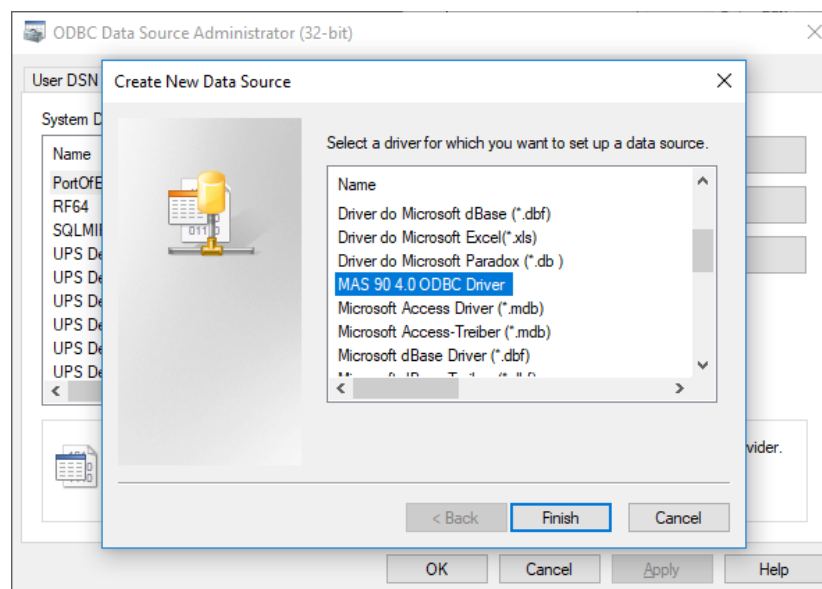
ODBC Setup

Note: The ODBC Data Source only needs to be setup once for FedEx and UPS. If you have already setup an ODBC Data Source for UPS you will not need to do it again for FedEx

To begin, go to the Windows 'Start' – 'Control Panel' – 'Administrative Tools' – 'Data Sources'
From the 'ODBC Data Source Administrator' screen select 'Add'



Select the MAS90 4.0 ODBC Driver and click 'Finish'.



Click on 'Finish'.

We will now need to fill in the options for the ODBC driver. Fill in the following fields for each 'Tab'

BASIC

Data Source Name: Type in SOTAMAS90_SHIP for the Data source name. Or if this is getting setup for multiple companies then make the data source name SOTAMAS90_XXX where XXX is the SAGE 100 company code.

Description: Reference field only.

Database Directory: This is the directory to your SAGE 100 installation. If this is a MAS200 install use a UNC path to the MAS90 directory.

LOGON

Company Code: Type in the SAGE 100 Company code this is getting linked to. (make sure to use Capital letters)

Default UserID: Type in the SAGE 100 user Id to login in as.

Password: Enter the SAGE 100 password for the user (this password is case-sensitive)

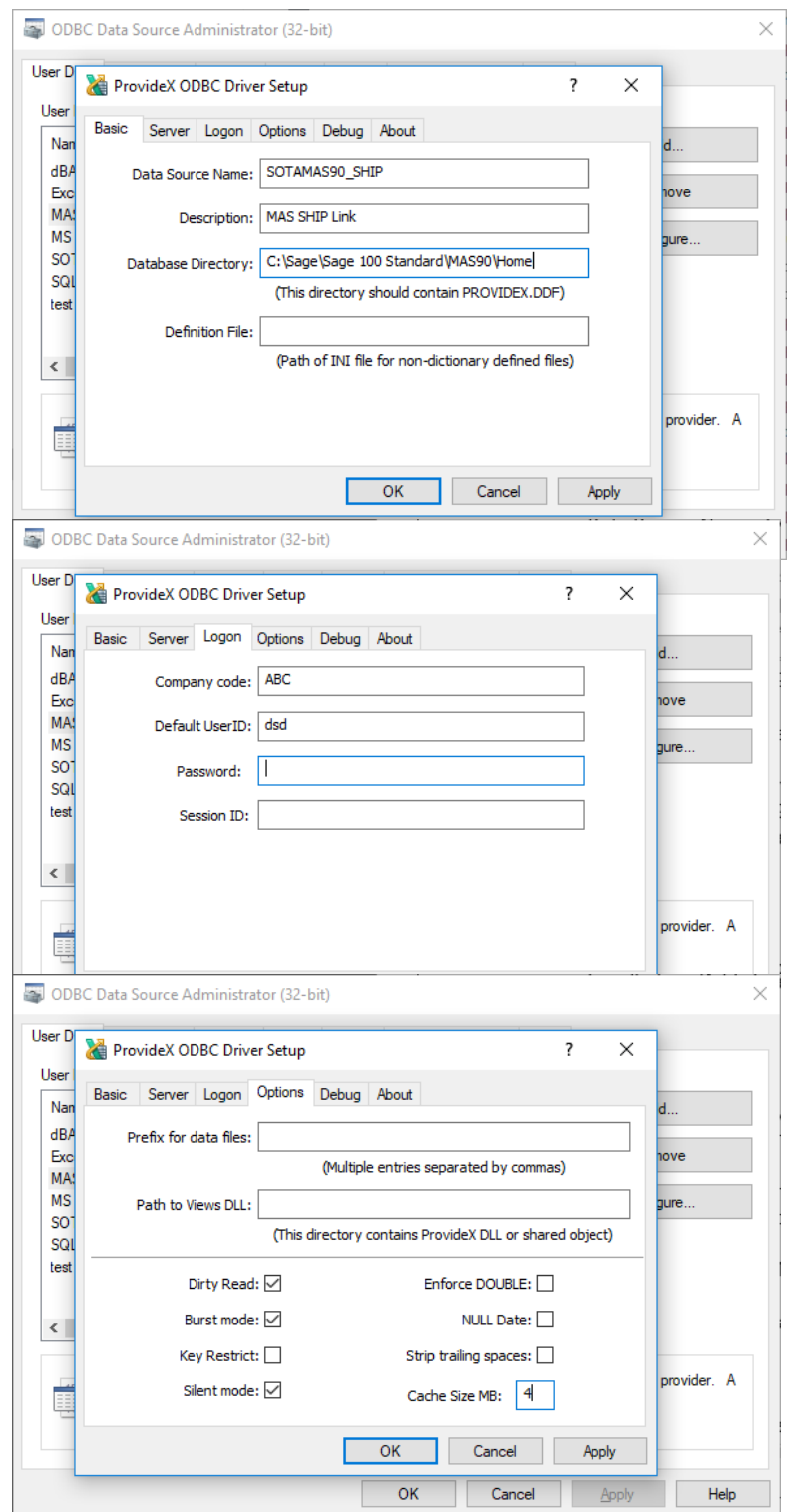
OPTIONS

Dirty Read: check this box on.

Burst Mode: check this box on.

Silent Mode: check this box on.

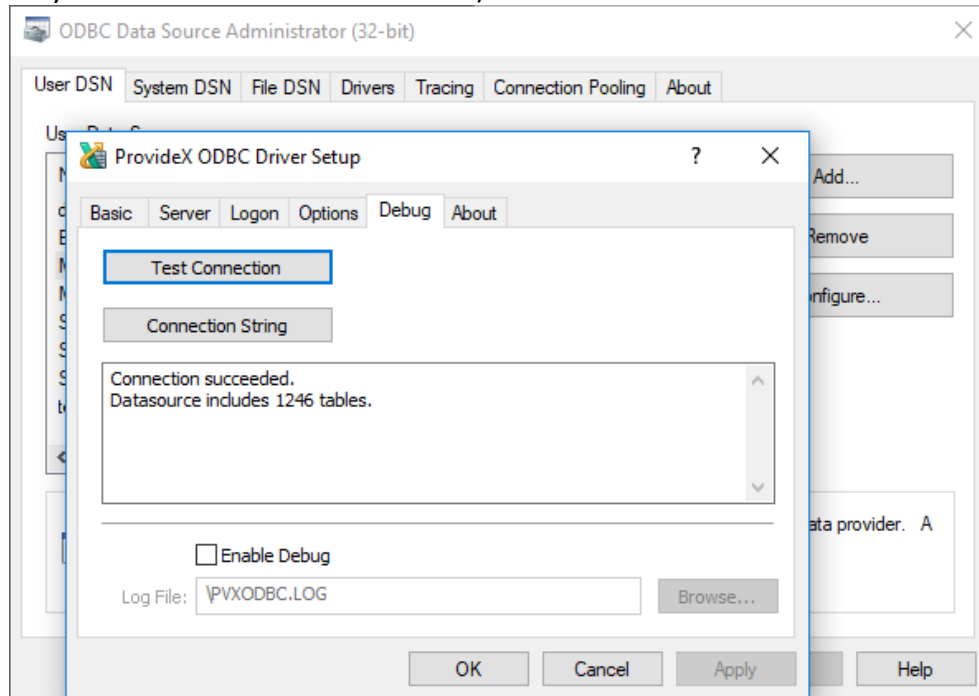
Cache Size MB: Set to 4



After the 'Options' have been set click 'Apply'.

DEBUG

Click on 'Test Connection' if everything is setup correctly you should receive a 'Connection Succeeded' message with the number of tables read. (number of tables can vary from installation to installation)



Fedex Ship Manager – Import/Export Setup

NOTE: This setup must be repeated on each workstation that has FedEx Ship Manager loaded and must be done at the FedEx workstation not the server.

INDEX – Once all the fields have been mapped click on the 'Index' button at the bottom and select SalesOrderNo as the Index value.



CONVERSION: To make sure fields convert correctly to the right value we need to match the SAGE 100 value to the FedEx value. The following fields need conversions set:

Residential Delivery

- No/False = N
- Yes/True = Y

Country – FedEx only has only a two character country code, SAGE 100 uses 3 characters. To make sure the FedEx and SAGE 100 values match up correctly you have two options.

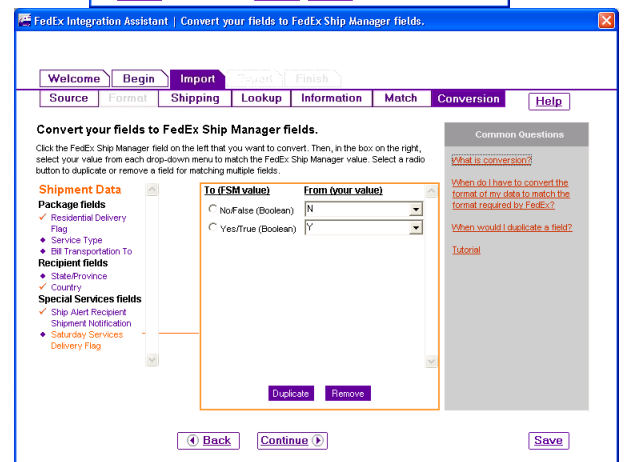
- Set your SAGE 100 country codes to match FedEx (*If you only use 2 characters in SAGE 100 and set them up the same as FedEx they will come over correctly without conversion*) or
- Go into the conversion tables and assign the FedEx country code to the correct SAGE 100 three character value.

Ship Alert Recipient

- No/False = N
- Yes/True = Y

Saturday Services Delivery Flag

- No/False = N
- Yes/True = Y



EXPORT DESTINATION: Select the destination as a 'Text File' and then browse and select the 'Manifest.csv' found in the ..\MAS90\MAS_ABC\SOABC directory where 'ABC' is the SAGE 100 company code you are linking to.

NOTE: You may need to create a 'Manifest.csv' file, if you do type in 1 thru 19 with each number separated by a comma

EXPORT FORMAT: Select the following options for the text file format

- Delimited
- {comma} – the character used to separate the fields
- 'No' for field headings

EXPORT METHOD: Select the Method for exporting the records processed in FedEx ship manager, select the following options.

- When do you want to export to your data source? – Each time a shipment is completed.
- How do you want to update your data source? – Insert a new record

EXPORT INFORMATION: Select the information to be exported. On the Information screen click on the 'All Fields' line and select the following fields.

FINISH: We are about finished with the integration, there are two more screens that will summarize what we have done and then ask us to 'Save' our settings.

SUMMARY: the summary screen will summarize what we have setup and give you an opportunity to change anything that has been setup, by clicking on the 'Edit' link for the appropriate section. If you are satisfied click

on the 'Continue' button

INSTRUCTIONS: Please read this screen and when finished click on the 'SAVE' button at the bottom right-hand corner. After clicking on 'Save' click on the 'FINISH' button.

SAVE: Give your profile a name, you can type in anything that will make sense, if you are setting this up for multiple companies be sure to include the MAS90 company code that you set it up for.

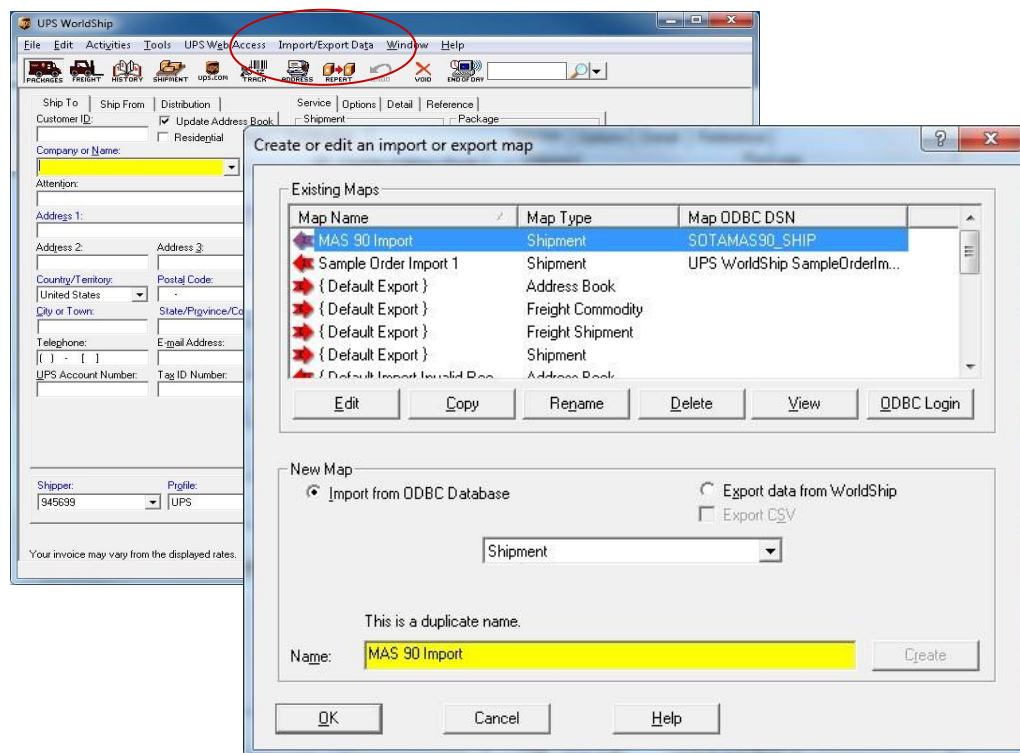

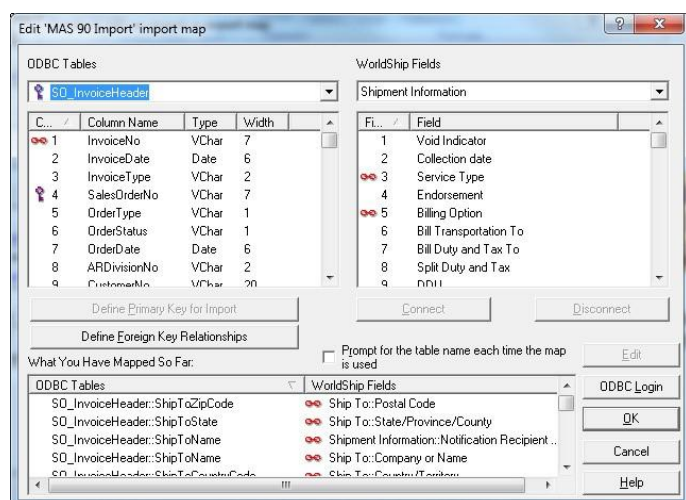
UPS WorldShip – Import/Export Setup

From the WorldShip Import/Export Data Menu, choose Create/Edit Map

On the lower portion of the window, in New Map, click the Import from ODBC Database, Select Shipment from the drop down, and enter a name for your Import Map. Click OK.

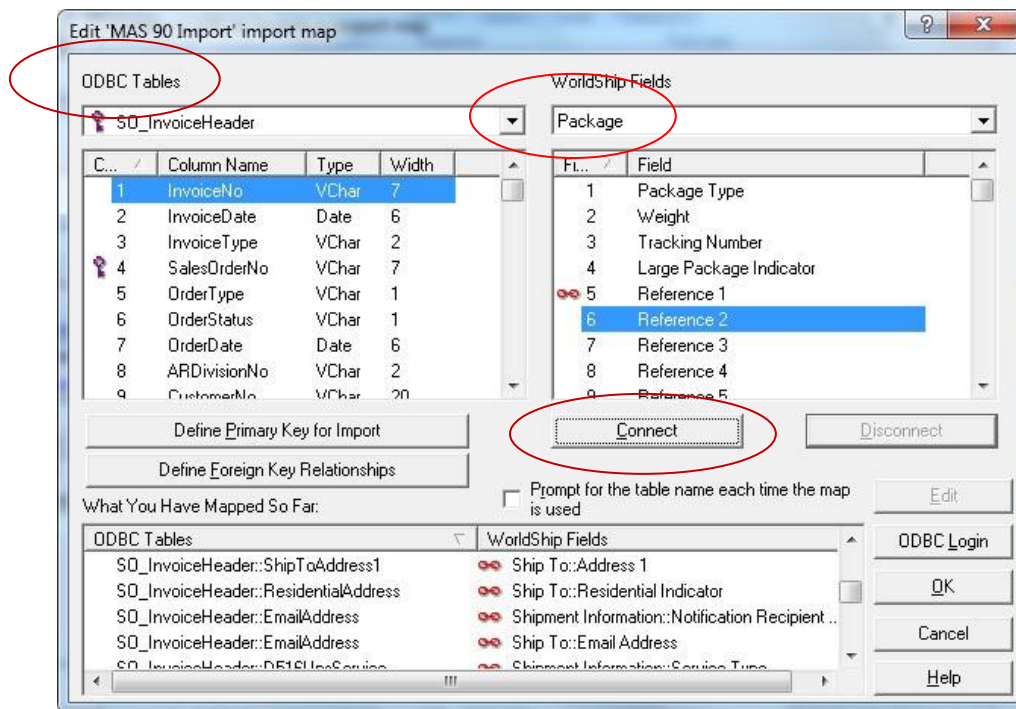


In the ODBC Tables column, select SO_InvoiceHeader



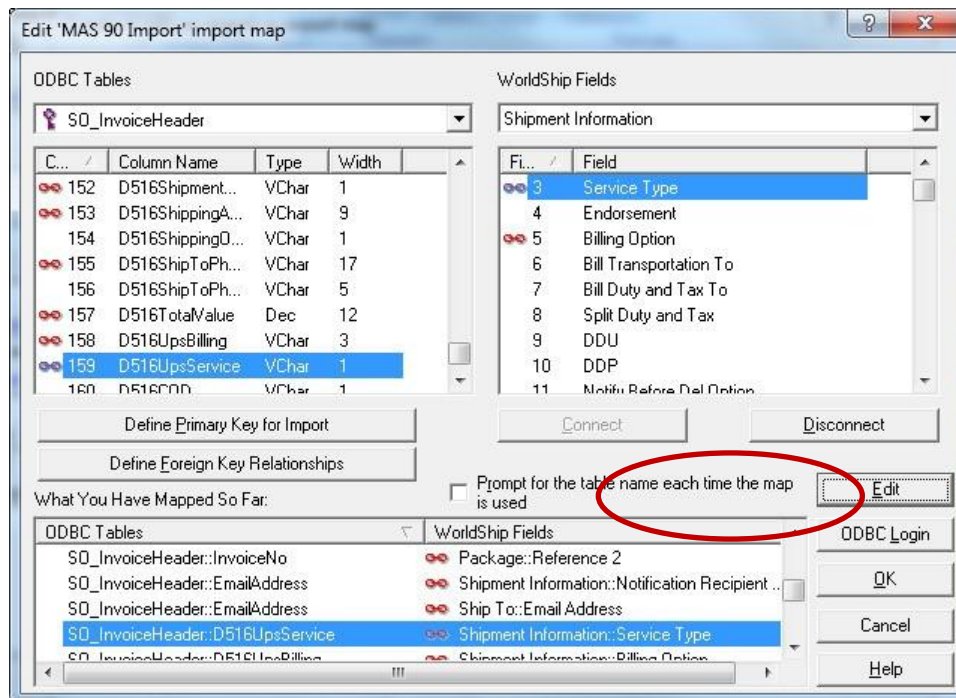
Map the SO_Invoice Header fields to the UPS fields as follows. The field numbers are listed for UPS WorldShip v15 (2012). The field numbers can change from version to version but typically the Table Name and Field Descriptions remain constant or at least similar enough to easily identify.

From the ODBC Table column, select field 1 from the SO_InvoiceHeader. Then select Package, Reference 2 from the WorldShip Package, Reference 2 field. Click the Connect button. Repeat this procedure for each MAS 90 field listed.



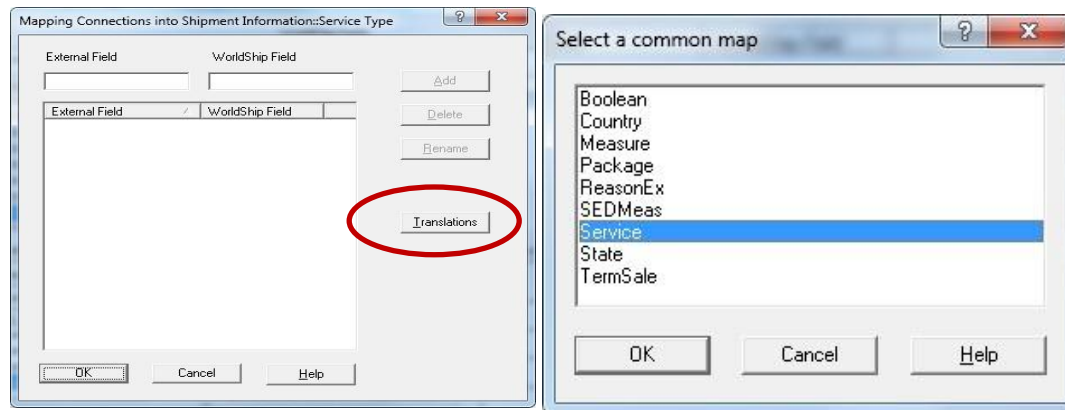

Go to 'Sales Order' – 'Setup' – 'Shipping Rate Maintenance'. You will need to identify each Shipping Rate Code as either 'UPS' or 'FedEx' and identify the different shipping options you want to have. These options are changeable in Sales Order entry or Shipping Data Entry.

- **Handling Charges:** Choose *None* if no handling charges are to be added to the freight exported from the Shipping Software to Shipping Data Entry. Choose *Per Package* if handling charges for each package in the shipment are to be added to the freight exported from the Shipping Software to Shipping Data Entry. Choose *Flat Rate* if handling charges for each complete shipment will be added to the freight exported from the Shipping Software to Shipping Data Entry. Enter the amount of the handling charges for each package.
- **Shipping Type:** Choose the appropriate carrier for the Shipping Code. Choose *None* for all carriers other than UPS or FedEx.
- **FedEx / UPS Billing:** Select the Billing method
- **FedEx / UPS Service Type:** Select the Service type.
- **Add Freight to Invoice:** Enable this option if the freight amount calculated in the Shipping Software should be written to the Freight field in Shipping Data Entry. This is appropriate

if the Shipping Code is for Billing Type Prepaid. Clear the check box if the freight amount calculated in UPS should not be exported from the shipping software to the Freight field in Shipping Data Entry. This is appropriate if the Shipping Code is for Billing Type Freight Collect or Consignee Billed.

Processing Shipments

Enter Shipping Data Entry per standard operating procedures. When finished, leave the entry screen OPEN (do not hit ACCEPT).

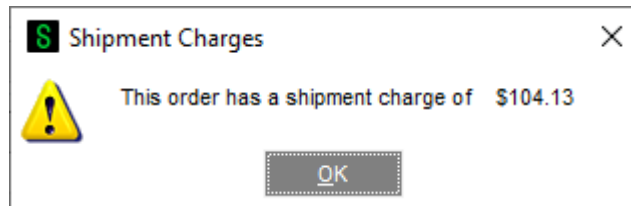
Open the Fedex Ship Manager or UPS Worldship Software and process the shipment.

If you are using Fedex Ship Manager, type in the Sales order number in the 'Customer Reference' field. Your shipment information should appear in FedEx. Complete the shipment in FedEx.

If you are using UPS Worldship, enter (or scan) the Sales Order number into the UPS Enter Import Key box. Process and Complete the shipment in UPS Worldship.

At this point the UPS / Fedex Export Map will send all the mapped fields to the Manifest.csv file identified during map creation.

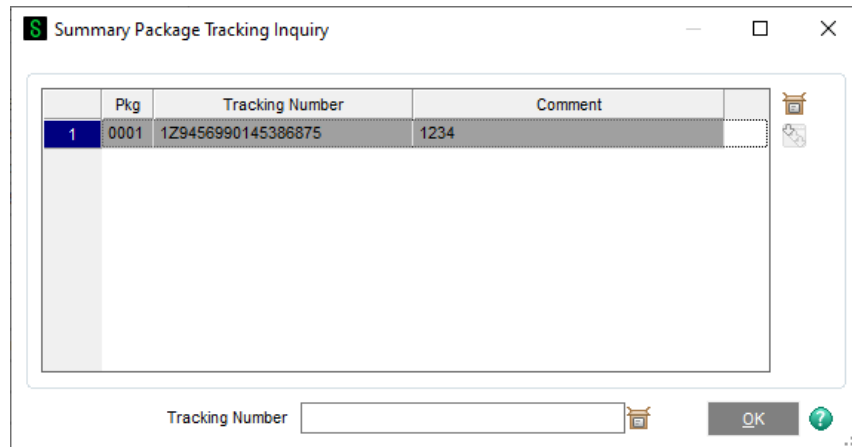
Return to the Sales Order Shipping Data Entry screen and click the Accept button to import the data into Shipping Data Entry and close the shipping window for this order. You will receive a message:



The Shipment Charge will be imported into the Freight field on the Totals Tab in Shipping Data Entry (if Shipping Rate Maintenance has the Add Freight to Invoice box checked).

In addition to the Shipment Charge, the Tracking Numbers are brought into Shipping Data Entry and can be viewed via the Tracking Button on the Shipping Tab.
