





Al-powered automation

- <u>AP Automation streamlined in Purchasing—Early Adopter:</u> This release continues the Early Adopter
 program to automate Purchasing transactions that do not have a source match defined, for example vendor
 invoices that do not match to purchase orders or requisitions.
- Mobile app now supports employee expense automation—Early Adopter: The Sage Intelligent Time
 mobile app now supports employee expense automation so that you can capture receipts, submit expense
 reports, and approve or decline them from a mobile device quickly.
- <u>Streamline your supplies workflow:</u> Ensure your team gets the supplies they need, when they are needed, by linking a new supplies request to an existing PO.
- <u>Customize supplies pick lists and pick reports:</u> Provide your team with detailed pick lists, and create more comprehensive pick reports.

Company and Administration

- New import service—General availability: The Sage Intacct import service simplifies data imports with Alpowered tools that handle all the complexity behind the scenes.
- <u>Authenticate and validate your email domain today</u>: To ensure smooth email delivery to your customers and partners, authenticate and validate your domain during May 2025.
- Updates to Accountant consoles:
 - Monitor the creation process of an instance or console template: After you create instances or console templates, the **State** column displays the following options: Ready, In progress, or Failed.
 - Changes during instance creation: The Production type field and the Demo option are no longer available when creating company instances from the Accountant console.
- Spanish and Canadian French language preferences—General availability: You can now set your preferred Company and User languages to Canadian French or Spanish.
- <u>Permission changes</u>: We changed permissions for Accounts Payable, Accounts Receivable, Expenses, Projects, and Time.

Accounts Payable

- <u>Issue checks to joint payees</u>: The joint check payment method is now available in Accounts Payable without a Construction subscription.
- Before you void a payment: A new message alerts you when an Accounts Payable transaction has already been reconciled.
- Import permission update: Post permissions required when importing non-draft adjustments.
- New rule type for named approvers: Select the User Level rule type to add bill approvers by name.
- Field change: Special characters are now restricted in certain Accounts Payable fields.

Accounts Receivable

- <u>Customer refunds—Coming soon!</u>: Record refunds that you make to customers against existing credits.
- <u>Inter-entity bill back improvements:</u> Locations and sublocations use bill back mapping from the parent entity.
- Receive a payment: We've postponed the retirement of Receive a payment.
- AR statement improvements: Applied external credits now appear in entity-level statements.

- Import permission update: Post permissions required when importing non-draft invoices and adjustments.
- <u>Before you reverse an advance</u>: A new message alerts you when a customer advance has already been reconciled.
- <u>Customer payment services retiring</u>: Our Authorize.net and PayPal integrations are going away on November 7, 2025. Check out Versapay, a Sage recommended solution, to continue accepting customer payments in Sage Intacct.
- Field change: Special characters are now restricted in certain Accounts Receivable fields.

Cash Management

- <u>Import credit card bank transactions for reconciliation</u>: Use Bank transaction assistant file import for an improved experience.
- <u>Classic import experience for reconciliation is retiring</u>: Instead, use Bank transaction assistant file import to import bank and credit card transactions.
- <u>Reclassify GL account for credit card transactions</u>: Update the GL account of paid, partially paid, and reconciled credit card transactions.

Consolidation

Affiliate entity dimension—General availability: Use the new affiliate entity standard dimension to track
inter-entity activity, enabling enhanced reporting and automated, more granular inter-entity eliminations for
companies with Consolidation subscriptions.

Contracts

- Introducing the Contract summary tab: Quickly get a high-level view of contract activity. Track key details like transactions for OE, AR, Purchasing, and AP, along with project insights, all in one place.
- <u>Edit custom fields on canceled contract lines</u>: You can now edit custom fields on canceled contract lines, allowing you to update information for reporting, compliance, or adjustment purposes without reactivating the contract.


